ELITE ACADEMY REGISTRATION FORM AND CONTRACT

Please read & review the following information. In consideration of membership as a student dancer at Elite Academy, the parent(s) and/or legal guardian of the minor participant named below are made aware of & agree to the following:

OFFICE HOURS: Elite Academy's office is open Monday-Thursday from 4:00 pm - 8:00 pm. A drop box has been provided for convenience to pay tuition and fees in form of check (DO NOT USE FOR CASH). I understand that Elite Academy is not responsible for lost or stolen cash.

MONTHLY TUITION AND FEES: I understand that monthly tuition, competition fees, team fees, concert fees, rehearsal fees, costume fees and any other fees are due on the first of the month. I understand that monthly tuition payments cover lessons taught from the first day of the month until the last day of the month. I understand that if I am paying by check I will need to include my child's FIRST and LAST name on the check. I understand that if I am paying cash an Elite Academy staff member must provide a receipt. I understand that if I am paying with credit card it will be ran during office hours. I understand that if I am going to be out of town or absent when the first of month occurs, it is my responsibility to make a payment. Payments must be made BEFORE THE 10th of the month to avoid a finance charge. All fees are non-refundable.

Elite Academy offers three payment options chose the best one that works for you.

PREFERED Option 1: Pay Monthly Fees with the Automatic Payment Plan. Tuition and monthly fees will be automatically debited or charged from your choice of debit or credit card on the first day of each month. Elite Academy accepts MasterCard, Visa and Discover. There is a 2% charge on all credit cards.

Option 2: **Pay Tuition and monthly fees by cash or check.**

Option 3: **Pay Tuition in full for the year.** Select this method and take a 10% discount off your yearly tuition.

FINANCE CHARGE: I understand that a \$10 finance charge will be added to accounts **on the morning of the 10th day of the month**. In addition, a \$10.00 finance charge will be assessed to accounts every subsequent tenth day that my child's account remains outstanding. I understand that if my check is returned a \$20 return check fee will be charged to my account.

CREDIT CARD PAYMENTS: I understand there is a 2% charge on all credit card transactions. I understand that if I am set up on Elite Academy monthly's credit card transaction list my card will be ran between the 1st and 9th of every month. I understand if my card is denied three (3) times it will be removed from the list. I understand that if my card is declined, there will be a \$5 fee. I understand that by signing this I give Elite Academy permission to run my credit card over the phone if I call in and request that they do so. I understand that my signature here will take place of my physical signature on my receipt.

PAST DUE ACCOUNTS: Students will not be allowed to participate if their account is **30** days past due. I understand that it is my responsibility to communicate with the Elite Academy office manager to avoid being sent to collections.

COLLECTIONS: I understand that if my account becomes delinquent **30** days or more, it will be turned over to a collection agency. I also agree that I will pay any additional charges equal to the cost of collection, including collection agency fees, attorney fees, and court costs incurred with or without suit and permitted by laws governing these transactions.

ORDERING MERCHANDISE: A merchandise form must be filled out if your child needs attire ordered. Merchandise will not be ordered until payment is received.

CLASS WITHDRAWALS: Parents must submit an add/drop form or send an email to the Elite Academy office manager (2) weeks prior to withdrawing from a class. If you do not fill out an add/drop form you will be responsible for monthly tuition until the form has been filled out. There are no refunds for partial attendance.

ELITE ACADEMY PROPERTY: Elite Academy property, including the building, will be treated with respect by students and parents. Disrespectful and disruptive behavior is not tolerated. All students and parents must remain quietly in the waiting area until an Elite Academy staff member escorts the students to class. All food and beverages must be disposed of properly and not left in the waiting areas. Students and parents are not to loiter in the hallways. No running, yelling, or horseplay is allowed.

NO REFUNDS: No credits or refunds will be given for classes untended. Students may make up a maximum of two (2) missed lessons per month. All missed lessons must be made up during the month classes were missed unless prior arrangements have been made with the teacher. All make up lessons must be scheduled with your student's teacher. Make up lessons do not apply to the competition teams. There will be no cash refunds for café cards, merchandise, attire, or any other Elite Academy fees. Credit only.

LOST AND FOUND: Elite Academy is not responsible for lost or stolen items. Any items left after hours will be placed in the lost and found in the locker room.

HEALTH INSURANCE: All students are required to carry their own health insurance. Elite Academy is not financially responsible for injuries occurring at our facility. Elite Academy strives to provide a safe training environment for our students, however injuries may still occur.

REGISTRATION FEE: A \$35.00 registration fee is assessed on an annual basis. All students are required to pay this fee. Registration for current students is \$25.00. Families with more than one student is \$50 per family.

CANCELLATION: Elite Academy reserves the right to cancel a student's membership at any time.

STUDIO RENTALS/PRIVATE LESSONS: I agree to pay for the instructed hours provided directly to the dance teacher and the studio rental fees listed on the studio rental form. The rental form must be filled out by an Elite Academy staff member. I am also aware that these hours cannot be refunded or credited towards any other fees.

ELITE ACADEMY WAIVER AND RELEASE

I am aware that dance, gymnastics and yoga are vigorous activities that pose a risk of injury. I understand that dance, gymnastics, cheerleading and other related activities involve certain risks, including, but not limited to, death, serious neck and spinal injuries, and the injury of bones, ligaments, and muscles. I also understand that mats and other safety equipment provided for the protection of my child, including the active participation of a coach or teacher who will spot or assist in the performance of certain skills, may be inadequate to prevent serious injury.

I understand that participation in dance, gymnastics, cheerleading and other related activities involves activities incidental to active participation in the aforementioned activities including moving from event to event, conditioning, stretching and other activities which may leave my child vulnerable to accidental or reckless actions of other participants who may not have complete control over their actions or may not be aware of other students in the facilities. The participation of my child is voluntary with the knowledge of the risks involved and I hereby agree to accept any and all inherent risks of property damage, personal injury, or death.

In consideration of my Child's participation at Elite Academy, I hereby release and covenant not to sue Elite Academy, the owners, staff, or other agents from any and all present and future claims resulting from ordinary negligence on the part of Elite Academy or others listed for property damage, personal injury, or wrongful death arising as a result of engaging in or receiving instruction in dance, gymnastics, cheerleading or other activities incidental to my Child's participation in the Elite Academy program. I hereby voluntarily waive any and all claims resulting from ordinary negligence, both present and past that may be made by me or others on behalf of me or my child.

I further agree to indemnify and hold harmless Elite Academy and the staff for any and all claims arising as a result of engaging in or receiving instructions in dance, gymnastics, cheerleading or any other activity incidental to my Child's participation.

I understand this waiver is intended to be as broad and as inclusive as permitted by the laws of the state of Utah and agree that if any portion is held invalid, the remainder of the waiver will continue in full legal force and effect.

In the event of an accident involving my child, I hereby release the staff of Elite Academy to render any first aid to my child, and if deemed necessary, to seek medical assistance, including transportation by a staff member or ambulance to any health care facility or hospital.

I also understand that I must have, and will continue to provide proper hospitalization, health, and accident insurance coverage for my child.

I affirm that I am of legal age and am freely signing this agreement. I have read this form and understand that by signing below, I am giving up legal rights and/or remedies which may be available to me for the ordinary negligence of Elite Academy or their staff.
